



It is with great enthusiasm that I submit this **Letter of Interest**, my **resume**, and a **Financial Disclosure Statement** to the Pima County Board of Supervisors for their consideration of my service as **Justice of the Peace of Pima County Judicial Precinct 7**.

My total resume outlines what I bring to the table, but **TEAMWORK** – building teams – **TO GET GOOD THINGS DONE** – in the work place, in the community, and in classroom – is my expertise.

Whether challenged to launch a start-up, manage a corporate Intellectual Property – Contracts group, or draw together a vibrant university/college learning community classroom, as a **Team Builder** I have consistently delivered strong results. 
