COUNT 7: ATTEMPT TO COMMIT MOLESTATION OF A CHILD, A CLASS 2 FELONY Dangerous Crime Against Children (Otoniel N Navarrete)

The Grand Jurors of Maricopa County, Arizona, accuse OTONIEL N NAVARRETE, on August 13, 2021, charging that in Maricopa County, Arizona:

COUNT 1:

OTONIEL N NAVARRETE, on or between July 1, 2017, and June 30, 2018, intentionally or knowingly did molest VICTIM A, a child under the age of fifteen years, by engaging in sexual contact with VICTIM A, a child under fifteen years of age, in violation of A.R.S. §§ 13-1401, 13-1410, 13-3821, 13-610, 13-705, 13-701, 13-702, and 13-801.

COUNT 2:

OTONIEL N NAVARRETE, on or between July 1, 2018, and June 30, 2019, intentionally or knowingly did engage in sexual intercourse or oral sexual contact with VICTIM A, who was a minor under the age of fifteen years, (TO WIT: Time in bedroom - defendant's rubbed the victim's penis), in violation of A.R.S. §§ 13-1401, 13-1405, 13-3821, 13-610, 13-705, 13-701, 13-702, and 13-801.

COUNT 3:

OTONIEL N NAVARRETE, on or between July 1, 2018, and June 30, 2019, intentionally or knowingly did engage in sexual intercourse or oral sexual contact with VICTIM A, who was a minor under the age of fifteen years, (TO WIT: same time as Count 2 - defendant put his mouth on the victim's penis), in violation of A.R.S. §§ 13-1401, 13-1405, 13-3821, 13-610, 13-705, 13-701, 13-702, and 13-801.

COUNT 4:

OTONIEL N NAVARRETE, on or between July 1, 2018, and June 30, 2019, intentionally or knowingly did engage in sexual intercourse or oral sexual contact with VICTIM A, who was a minor under the age of fifteen years, (TO WIT: time on couch), in violation of A.R.S. §§ 13-1401, 13-1405, 13-3821, 13-610, 13-705, 13-701, 13-702, and 13-801.

COUNT 5:

OTONIEL N NAVARRETE, on or between July 1, 2019 and June 30, 2020, intentionally or knowingly did engage in sexual intercourse or oral sexual contact with VICTIM A, who was a minor fifteen years of age or over, (TO WIT: defendant rubbed the victim's penis), in violation of A.R.S. §§ 13-1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, and 13-801.

COUNT 6:


OTONIEL N NAVARRETE, on or between July 1, 2019, and June 30, 2020, intentionally or knowingly did engage in sexual intercourse or oral sexual contact with VICTIM A, who was a minor fifteen years of age or over, (TO WIT: same time as Count 5 - defendant put his mouth on the victim's penis), in violation of A.R.S. §§ 13-1401, 13-1405, 13-3821, 13-610, 13-701, 13-702, and 13-801.

COUNT 7:

OTONIEL N NAVARRETE, on or between May 1, 2018, and August 31, 2019, intentionally or knowingly did attempt to molest VICTIM B, a child under the age of fifteen years, by engaging in sexual contact with VICTIM B, a child under fifteen years of age, in violation of A.R.S. §§ 13-1001, 13-1401, 13-1410, 13-3821, 13-610, 13-705, 13-701, 13-702, and 13-801.
